## SUSSEX COUNTY CRICKET CLUB COMMITTEE MEMBERS: 1858 to 1996

The list below gives brief details of all 322 individuals – 319 men and three women – who were full members of the committee overseeing the operations of the Sussex County Cricket Club between the start of the 1858 season and the end of the 1996 season, 139 years in all.

The start date has been chosen because 1858 was the first year of the 'reformation' of the club under the secretaryship of Bridger Stent, a Brighton solicitor, following the annual general meeting towards the end the 1857 season. The end date has been chosen because 1996 was the last season before a similar instance of régime change, 'the revolution', at the annual general meeting in March 1997.

The details provided for each individual comprise, where appropriate and where the information is available: (1) surname and forenames; (2) date and place of birth; (3) secondary schools and higher education institutions attended; (4) details of UK residence; (5) seasons of membership on the committee and officer positions held, if any; (6) occupations; (7) achievements in the public eye, including civilian and military honours; (8) significant cricket-playing achievements, including Test appearances; (9) achievements at national or international level in other sports; (10) details of close relatives who played first-class cricket for the county or were county committee members; (11) date and place of death. Abbreviations used in the list are explained in Appendix Two.

Among other things the list shows the shift in committee membership from landed gentry, many holding lieutenancy and magistrates' positions, in the nineteenth century towards a greater representation of commercial expertise, some connected with the City of London, in more recent times. For some committee men – they were almost entirely men – membership was part of a wider pattern of overseeing public organisations of various kinds; they were politicians. Army officers, brewers, clerics and prep-school teachers can be found in fair numbers at different periods: few were industrialists. Eighty-two, about a quarter, played first-class cricket in their time, many a few matches as an amateur. Eighty-five had an Oxbridge background.

Further notes at the end of the list deal with the sometimes complicated arrangements covering membership of the Club's committee and the sources of the biographical data given here.

**Sources** The names given derive mainly from research of local newpapers, particularly the *Sussex Agricultural Express*, for the earliest years of the Club's operations; from listings given in *James Lillywhite's Cricketers' Annual*, *John Lillywhite's Cricketers' Companion* and the *Wisden Cricketers' Almanack* in the later nineteenth century; from research of the Club's committee minutes, annual reports and handbooks published by or for the Club itself, for the period from 1892 onwards.

The biographical details come from a very wide range of sources. For basic births and deaths information, genealogy websites (giving access to Census, public register, probate, phone book and other data) have been used, as well as the CricketArchive website. For more personal information, the County Club's own publications have been helpful, as well as the cricket press, including various almanacks, annuals and magazines. Local and national newspapers have also been an important source. Thanks are owed to several former committee members, to volunteer colleagues at the Sussex Cricket Museum for their recollections; to various members of the Association of Cricket Statisticians and Historians, to experts at the Sussex Family History Group (particularly David Kent), and to various local historians. These have all freely contributed a sizeable number of detailed pieces of information. Inevitably there remain gaps in the material: these 'known unknowns' can, we hope, be filled in piece by piece in the future. Additional or corrected information would be welcomed by the compiler at davidjeater@yahoo.co.uk.

Committee membership From its earliest years, individuals were elected by the Club's members to the committee, usually for a three-year period, mostly running from March. It seems that, in practice, until the second half of the twentieth century, elections were often uncontested, with some stalwarts being committee members for thirty years and more. Thus minutes sometimes refer to members being appointed, rather than elected, to the committee. From time to time, minutes also refer to vacancies, and there is evidence that election candidates were subject to a vetting process. For many years some committee members had an important liaison role with various 'cricket weeks' around the county.

Throughout most of the period covered by this compilation, the committee comprised representatives of different areas of the county, originally five from each of Brighton and District, East Sussex and West Sussex. These were increased to six for each area in 1876. From 1907 onwards, East and West Sussex were broken up into smaller districts for representation purposes, with areas having larger Club membership receiving more committee places than areas with fewer members. By 1972 the committee had 37 members, plus chairman and treasurer. In 1974 the constitution was changed so that elections were held to a Representative Council some forty in number, with a committee of fourteen being drawn from that body. This two-tier arrangement was dismantled in 1978 and replaced by a committee of twenty drawn from seven districts. (The listing gives the names only of those who were members of both the committee and the Representative Council between 1974 and 1977.) A smaller committee of nine members came into operation in 1990, though in some

years this was increased by co-option. These changes in the size of the committee relate, of course, to large changes in the functions of the committee and those of the Club's paid staff.

For a brief period after 1878, the County committee included one delegate from each of four local clubs, Chichester, Eastbourne, Hastings and Horsham. The delegate sent by a local club might change from meeting to meeting and these have therefore been omitted from the list.

Until 1950 the Club appointed vice-presidents for their services to the Club, to local cricket or to enhance the Club's prestige, who were were eligible, rather like aldermen in pre-1974 local government, to attend the committee and vote on its business, though only a few actually chose to do so. (There were five vice-presidents in 1890, ten in 1899, sixteen in 1928 and twelve in 1945.) Because they were mostly absentees, vice-presidents are omitted. In the list above, a dagger shows chairmen who undertook this position while serving as vice-president, *i.e.* while not an elected committee member. (In 1919 Lord Leconfield chaired the committee while also acting as club president.) The Club, of course, continues to appoint vice-presidents in recognition of their services to the local game and to the county generally but from 1950 they had no *ex-officio* right to vote on committee business. After 1950, some vice-presidents contested and were successful in elections for their areas.

The position of the first-team captain has, of course, always been an important one in running the club. Although captains have usually been members of sub-committees dealing with specifically cricket matters, and very often attended full committee meetings, it seems that captains have not been *ex-officio* members of the Club's main committee during the period 1858 to 1996 and they do not appear in the list above. (The names of captains can be found in various publications about Sussex cricket and in the *Wisden Book of Cricket Records*.)

Committee officers There have, of course, been specific posts of chairman, secretary and treasurer. In the first few years after 1858, it appears these postholders were drawn from the committee itself, but from about 1862 secretary and treasurer were separately elected. After E.A.Bruce retired after the 1913 season, secretaries (with the exception of G.S.Godfree from 1916 to 1918 and Sir Home Gordon from 1943 to 1945, who voluntarily undertook the task in wartime) were not members of the committee, but were the paid head of the Club's administration, advising the committee and implementing its decisions. The treasurer was a full member of the committee from the start of the separate election to that post from 1862.

The position of chairman is less clear. Perhaps the intention at the outset was that presidents would chair the committee and the annual general meeting of the club, but in practice they didn't do so regularly. Press reports of the period 1858 to 1879 refer from time to time to a chairman, though it isn't always clear whether the individual concerned simply presided over the annual meeting or regularly chaired the committee itself. From 1880 there are more regular reports about chairmen, so the list above gives details of postholders from that date.

Following the reorganisation in 1974 the position of vice-chairman assumed more importance and details are given of these postholders from that date.

**Presidents** The Club has a long tradition of appointing a president as the head of its organisation from the ranks of eminent individuals with a Sussex connection, or as thanks for services to the game in Sussex. Between 1858 and 1996, there were 41 presidents. Of these, sixteen had been elected to the committee at one time or another: these are identified in the list above. Appendix One below gives details of the remaining 25 who took on the presidency without having been an elected committee member.

## **Appendix One**

This note gives details of 25 individuals who were presidents of the Sussex County Cricket Club, but were not apparently elected to the Club committee at any stage. Some of them helped the club mightily and exercised great influence on the Club's activities.

ATHLONE, first Earl of b 14.v.1874 Kensington, Middlesex: ed Eton C; Royal Military C, Sandhurst: president 1934: Army officer who reached the rank of major-general, diplomat, educationalist, landowner: chaired inquiries into medical education 1921 and 1937; Governor General of South Africa 1928-1931; Governor General of Canada 1940-1946: awarded DSO 1901; appointed GCVO 1904 for services to the monarchy, GCB 1911 and CMG 1920 for military services, GCMG 1923 on appointment to South Africa; Privy Counsellor 1931: d 16.i.1957 Kensington, Middlesex. (Registered as Alexander Augustus Frederick William Alfred George, Prince Alexander of TECK, but relinquished this and other titles 1917, taking the surname CAMBRIDGE when created first Earl of Athlone. His landholdings included Brantridge Park, Balcombe.)

BRASSEY, first Earl b 11.ii.1836 Stafford: ed Rugby S; Oxford U: president 1902: author, barrister, diplomat, landowner, magistrate, politician, statistician: Liberal MP for Devonport 1865, for Hastings 1868-1886; Civil Lord of the Admiralty 1880-1884, junior minster Admiralty 1884; Lord-in-Waiting 1893-1895; Governor of Victoria 1895-1900; editor *Naval Annual* and other publications 1886-1892: president Royal Statistical Society 1879-80; chairman Royal Commission into Anglo-Asian opium trade 1895: well-known yachtsman, circumnavigated the world 1876-77 in schooner *Sunbeam*, the first such achievement in a private yacht: deputy lieutenant for Sussex; created first Baron Brassey 1886, appointed KCB (knighted) 1906, created first Earl Brassey 1911, for public services: father of Viscount Hythe (see below): d 23.ii.1918 Westminster, Middlesex. (*Formally identified as Thomas BRASSEY; his father was a well-known railway contractor*.)

**BUCHANAN, James** b 16.viii.1849 Brockville, Ontario: UK resident from an early age: president 1912: whisky distiller, later landowner, pedigree cattle breeder: managing director James Buchanan and Co , later chairman Buchanan-Dewar (whisky distillers); director Distillers Ltd: High Sheriff of Sussex 1910; created first Buchanan baronet 1920 for public and local services, first Baron Woolavington, of Lavington 1922 for services to charity; appointed GCVO (knighted) 1931 for services to the monarchy: well-known racehorse breeder and owner: d 9.viii.1935 East Lavington.

CAMPION, Sir William Robert b 3.vii. 1870 Westminster, Middlesex: ed Eton C; Oxford U: president 1932: landowner, diplomat, politician, stockbroker: Conservative MP for Mid-Sussex 1910-1924; Governor of Western Australia 1924-1931: awarded DSO 1917; appointed KCMG (knighted) on Western Australian appointment (see above); deputy lieutenant for Sussex: son of W.H. (see above); grandson of W.J. (see above): d 2.i.1951 Hassocks.

CASTLE STEWART, seventh Earl b 6.viii.1889 Newtownstewart (Co Tyrone), Ireland: ed Charterhouse, Godalming; Cambridge U; Sorbonne, Paris: president 1926: barrister, landowner, magistrate, politician, teacher: succeeded his father as seventh Earl Castle Stewart, in the Irish peerage, 1921, two older brothers having been killed in action; Conservative MP for Harborough 1929-1933: d 5.xi.1961 Nutley, by his own hand. (Registered as Arthur STUART. Styled 'Honourable' from 1914 to 1921.)

CHICHESTER, sixth Earl of b 21.v.1871 St Pancras, Middlesex: ed Eton C; Cambridge U: president 1920: landowner, magistrate, stockbroker: succeeded his father as sixth Earl 1905: member Public Works Loan Commission: appointed OBE for military services 1918, deputy lieutenant for Sussex: son of Hon F.G.Pelham, later fifth Earl of Chichester (played eight fc matches for Sussex): d 14.xi.1926 Stanmer, from pneumonia. (*Registered as Joceleyn Brudenell PELHAM. Styled 'Honourable' from 1902 to 1905.*)

**CURTEIS, Herbert Mascall** b 8.i.1823 Florence (Tuscany), Italy: UK resident from an early age: ed Westminster S; Oxford U: president 1869-1878: landowner, politician: played 57 fc matches, incl 43 for Sussex: Conservative MP for Rye 1847-1852: father of H. (played one fc match for Sussex) and R.M. (played nine fc matches for Sussex): d 16.vi.1895 Wartling.

**DEVONSHIRE, ninth Duke of** b 31.v.1868 Marylebone, Middlesex: ed Eton C; Cambridge U: president 1910: diplomat, landowner, magistrate, politician: succeeded his uncle as ninth Duke of Devonshire 1908: Conservative MP for West Derbyshire 1901-1908; Treasurer of the Household 1903-1905; junior minister Treasury 1905-1908; Lord of the Admiralty 1915, 1916; Governor General of Canada 1916-1921; Secretary of State for Colonies 1922-1924 (in cabinet): appointed Privy Counsellor 1908, GCVO for services to the monarchy 1911, GCMG and KG on appointment as Governor-General of Canada 1916: d 6.v.1938 Chatsworth, Derbyshire. (*Registered as Victor Christian William CAVENDISH*.)

**DU CROS, Arthur Philip** b 26.i.1871 Dublin, Ireland: president 1913: junior civil servant, later industrialist, politician: founder, later managing director, deputy-chairman Dunlop Rubber; Conservative MP for Hastings 1908-1918, for Clapham 1918-1922: created first Du Cros baronet 1916 for public services: provided his house at Bognor to King George V for convalescence 1929: d 28.x.1955 Watford, Hertfordshire.

**GAGE, sixth Viscount** b 30.xii.1895 Kensington, Middlesex: ed Eton C; Oxford U: president 1927: landowner, magistrate, politician: succeeded his father as sixth Viscount Gage, of Firle, in the Irish peerage 1912, at age 16: junior minister India Office 1924-1929, Lord-in-Waiting 1931-1939; chairman East Sussex County Council appointed KCVO (knighted) 1939 for services to the monarchy: d 27.ii.1982 South Africa. (*Registered as Henry Rainald GAGE. Styled 'Honourable' until 1912*.)

**HAILSHAM, first Viscount** b 28.ii.1872 Westminster, Middlesex: ed Eton C: president 1931: sugar merchant, later barrister, circuit judge, magistrate, politician: Conservative MP for St Marylebone 1922-1928; Attorney General 1922-1924 and 1924-1928; Secretary of State for War 1931-1935; Lord Chancellor 1935-1938; Lord President of the Council 1938; director Legal and General (insurance): appointed Privy Counsellor 1922, knighted 1922, created first Baron Hailsham 1928 and first Viscount Hailsham 1929: president MCC 1933-34: d 16.viii.1950 Hellingly. (*Registered as Douglas McGarel HOGG*.)

**HARBEN, Sir Henry** b 23.viii.1823 Holborn, Middlesex: president 1901, 1906: actuary, insurance company manager, landowner, local politician, magistrate: secretary, later director, then chairman, Prudential Assurance: mayor Hampstead 1900: deputy lieutenant for Sussex; knighted 1897; High Sherriff of Sussex 1898: great-grandfather of H.E.S. (played four fc matches, all for Sussex): d 2.xii.1911 Warnham.

**HYTHE, Viscount** b 7.iii.1863 Battle: ed Eton C; Oxford U: president 1914: author, chartered naval architect and civil engineer, landowner, magistrate, politician: director mining and smelting companies; editor *Naval Annual* and other publications 1892-1914: deputy lieutenant for Sussex: son of first Earl Brassey (see above), succeeding him as second Earl 1918: d 12.xi.1919 Westminster, Middlesex, from injuries received in road accident. (*Registered as Thomas Allnutt BRASSEY. Styled 'Honourable' from 1886 to 1911, Viscount Hythe from 1911.*)

**LECONFIELD, second Baron** b 31.vii.1830 Brighton: ed Eton C; Oxford U: president 1900: Army officer, landowner, magistrate, politician: Conservative MP for West Sussex 1854-1869: succeeded his father as second Baron 1869: deputy lieutenant for Sussex: father of third Baron Leconfield (see above): d 6.i.1901 Westminster, Middlesex. (*Formally identified as Henry WYNDHAM. Styled 'Honourable' from 1859 to 1869*.)

MILLER-HALLETT, Alexander Miller b 1856 Paddington, Middlesex: president 1937-1946: antimony refiner and merchant, brewer, farmer: director Hallett and Fry (antimony refinery), Tamplin and Sons (brewing); president Sussex County Agricultural Society: well-known epée fencer in 1880s: d 14.ii.1953 Rottingdean, at age 97, the longest lived of the County Club's presidents. (*Changed surname from Hallett to Miller-Hallett 1877, keeping Miller as forename.*)

NAWANAGAR, nineteenth Maharaja Jam Sahib of b 10.ix.1872 Sarodar (Kathiawar), India: ed Rajkumar C, Rajkot; Cambridge U: UK resident most years 1888-1904 and intermittently thereafter: president 1930: cricketer, diplomat, landowner, politician: played 307 fc matches, incl 211 for Sussex and 15 Tests for England: *Wisden* cricketer 1897: installed as nineteenthth Jam Sahib of Nawanagar 1907, later (c 1921) granted use of the title Maharaja; member Indian delegation to League of Nations 1921-1923; chancellor Indian Chamber of Princes 1932, 1933: appointed KCSI (knighted) 1917, GBE 1919 and GCSI 1923 for public services in India: d 2.iv.1933 Jamnagar (Kathiawar), India. (*Before 1907 usually identified as RANJITSINHJI Vibhaji in India and as Kumar Shri RANJITSINHJI in Britain*.)

NORFOLK, fifteenth Duke of b 27.x.1847 Westminster, Middlesex: ed Oratory S, Woodcote: president 1897, 1915, 1916: courtier, hymnologist, landowner, politician: succeeded his father as fifteenth Duke of Norfolk (and Earl Marshal) 1860, at age 12: Postmaster General 1895-1900, Mayor of Sheffield 1897, Mayor of Westminster 1900; editor Catholic hymnal: Lord Lieutenant of Sussex 1905-1917; appointed KG (knighted) 1886, Privy Counsellor 1895, GCVO 1902: father of sixteenth Duke of Norfolk (see below): d 11.ii.1917 Westminster, Middlesex. (Registered as Henry FITZALAN-HOWARD. Styled Baron Matravers until 1856, Earl of Arundel and Surrey from 1856 to 1860. He established the ground at Arundel Castle on which 38 fc and 20 limited-overs List A matches have been played since 1990.)

NORFOLK, sixteenth Duke of b 30.v.1908 Arundel: ed Oratory S, Woodcote: president 1933, at age 24 yr 10 mth, the youngest such postholder, and1949-1973: Army officer, courtier, landowner, magistrate, politician: succeeded his father as sixteenth Duke of Norfolk (see above) 1917, at age eight: junior Minister for Agriculture 1941-1945: appointed Privy Counsellor 1936, KG 1937, GCVO 1946 for services to the monarchy, GBE 1968 for services to the Territorial Army; Lord Lieutenant of Sussex 1949-1974; president MCC 1957-58: d 31.v.1975 Arundel. (Registered as Bernard Marmaduke FITZALAN-HOWARD. Styled Earl of Arundel and Surrey until 1917.)

RICHMOND, seventh Duke of b 27.xii.1845 Marylebone, Middlesex: ed Eton C: president 1905: Army officer, landowner, magistrate, politician: succeeded his father as sixth Duke of Richmond and Gordon 1903: Conservative MP for West Sussex 1869-1885, for Chichester 1885-1889: appointed CB for military services 1902, GCVO and KG (knighted) for services to the monarchy 1904: Lord Lieutenant of Elginshire 1902-1928; deputy lieutenant for Sussex: father of Lord Bernard Gordon-Lennox (Sussex committee 1913, 1914): d 18.i.1928 Goodwood. (Registered as Charles Henry GORDON-LENNOX. Styled Lord Settrington until 1860 and then Earl of March until 1903.)

RICHMOND, tenth Duke of b 19.ix.1929 Paddington, Middlesex: ed Eton C; William Temple C, Rugby: president 1991-2000: chartered accountant and manager, landowner: succeeded his father as tenth Duke 1989: director Ajax Insurance, John Wiley (publishing) and other companies; Church Commissioner: deputy lieutenant of West Sussex, Lord Lieutenant of West Sussex 1990-1994; member central committee World Council of Churches c 1990: d 1.ix.2017 Chichester. (Registered as Charles Henry GORDON-LENNOX. Styled Lord Settrington from 1929 to 1935 and then Earl of March until 1989.)

SHEFFIELD, third Earl of b 18.i.1832 Marylebone, Middlesex: ed Eton C: president 1858-1869, 1879-1896, 1904, thirty-one seasons in all, more than any other such postholder: diplomat, landowner, politician: played one fc match, for Sussex: Conservative MP for East Sussex 1857-1865; director railway companies: succeeded his father as third Earl of Sheffield 1876: d 21 iv.1909 Beaulieu-sur-Mer (Alpes-Maritimes), France. (Formally identified as Henry North HOLROYD. Styled Viscount Pevensey until 1876. His private ground at Sheffield Park, Fletching staged nine fc matches 1881-1896.)

WINTERTON, sixth Earl b 4.iv.1883 Westminster, Middlesex: ed Eton C; Oxford U: president 1908, 1922, 1923: landowner, politician: succeeded his father (see main text above) as sixth Earl Winterton in the Irish peerage 1907: Conservative MP for Horsham 1904-1918 and 1945-1951, for Horsham and Worthing 1918-1945; junior minister for India 1922-1924, and 1924-1929; Chancellor of the Duchy of Lancaster (in the cabinet) 1937, 1938; Paymaster-General 1939: appointed Privy Counsellor 1924; created first Baron Turnour, of Shillinglee 1952: d 26.viii.1962 Eastbourne. (Registered as Edward TURNOUR. Styled Viscount Turnour until 1907.)
